How to find us

Pacific Place is anchored at the heart of Hong Kong Island atop the MTR and backed by verdant parkland.



By MTR

Admiralty MTR station — the interchange for the Island, Tsuen Wan and South Island lines — is directly beneath Pacific Place, providing access to the entire MTR and Airport Express networks. Trains run from 6am - 1am.

Journey Times:

- Central - 3 mins
- Causeway Bay - 6 mins
- Airport - 35 mins
- Tsim Sha Tsui - 5 mins

Taxi ranks are located on Level 4 of Pacific Place Drive, outside Two Pacific Place.

By bus

Bus stops for more than 50 routes stand outside Pacific Place, connecting with Hong Kong Island, Kowloon, the New Territories, and the airport.



By car

With a total of more than 400 parking spaces, you can park at Pacific Place via the entrance on Level 4 of Pacific Place Drive off Justice Drive, or drive up Wing Fung Street from Queen's Road East to the carpark at Three Pacific Place.

Effective from 1 January 2024, parking costs HK\$35 per hour; payment can be made by Visa, MasterCard or Hong Kong's stored-value Octopus card.
