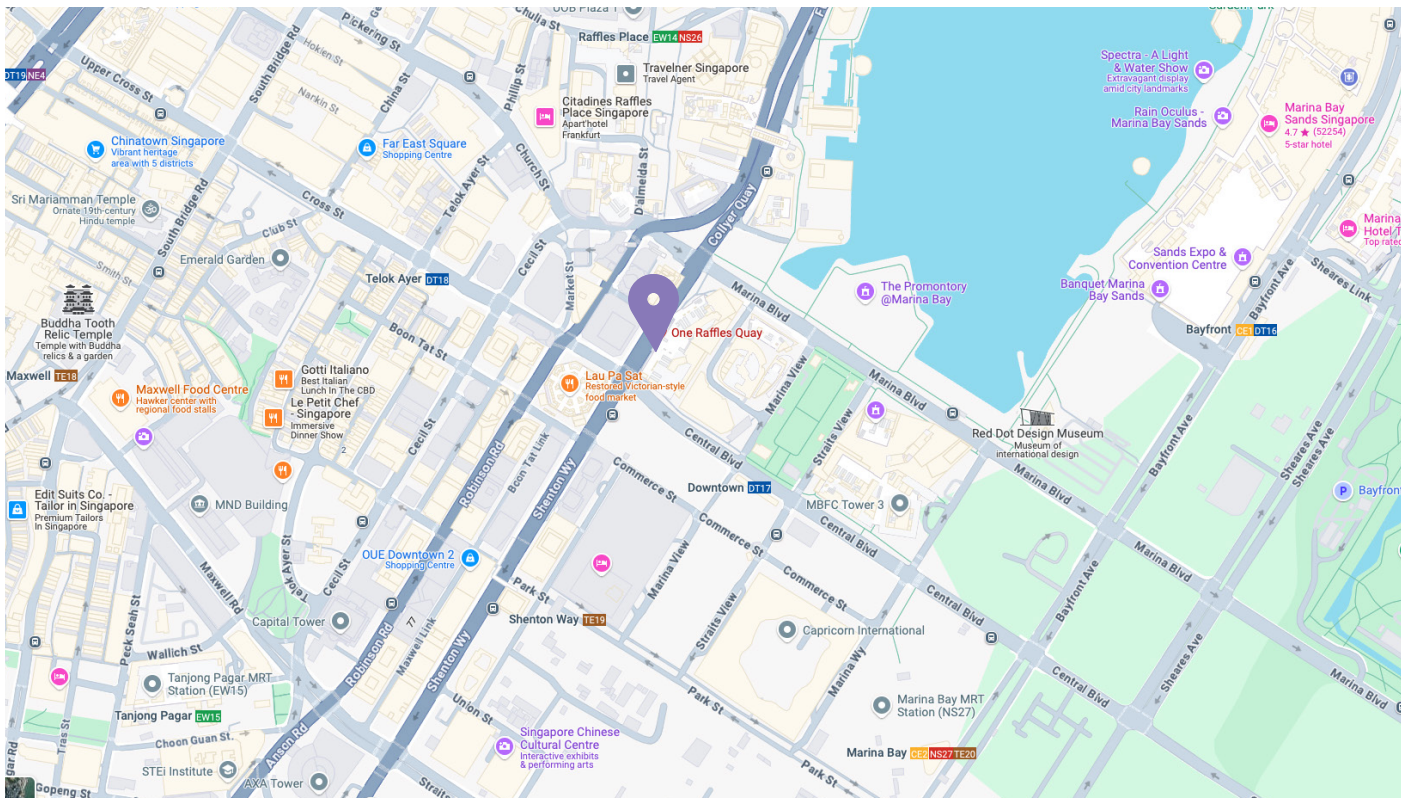

How to find us

Strategically located between Raffles Place and Marina Bay, One Raffles Quay (ORQ) serves as a gateway between Singapore's traditional Business District and the New Downtown. Raffles Place MRT Station

- Directly accessible via Exit J

Downtown MRT Station

- Exit E to Central Boulevard – linked to ORQ via IOI Central Boulevard Towers.
- Exit D to Marina Bay Link Mall – linked to ORQ via Marina Bay Link Mall and The Sail underground pedestrian network.
