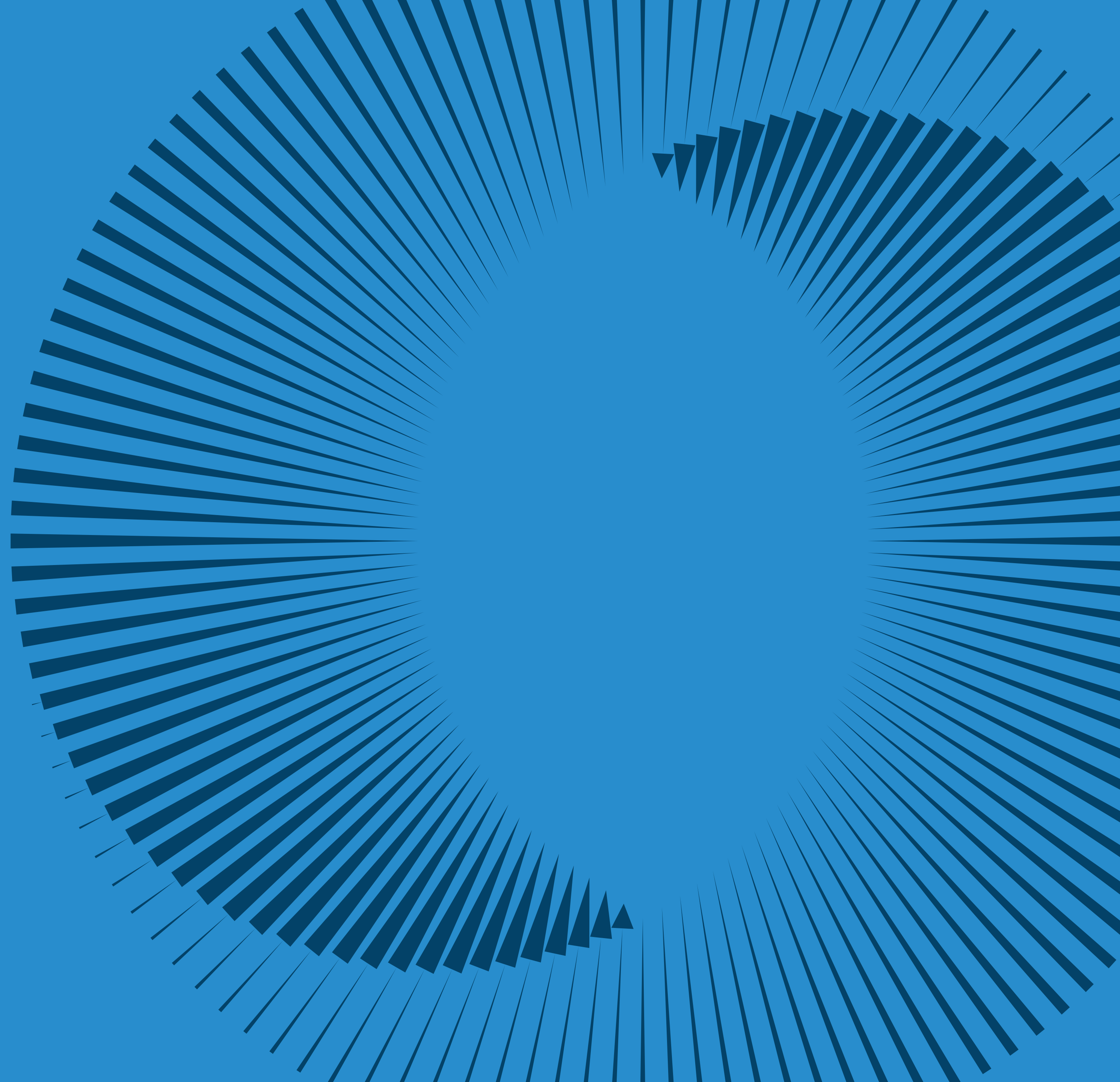

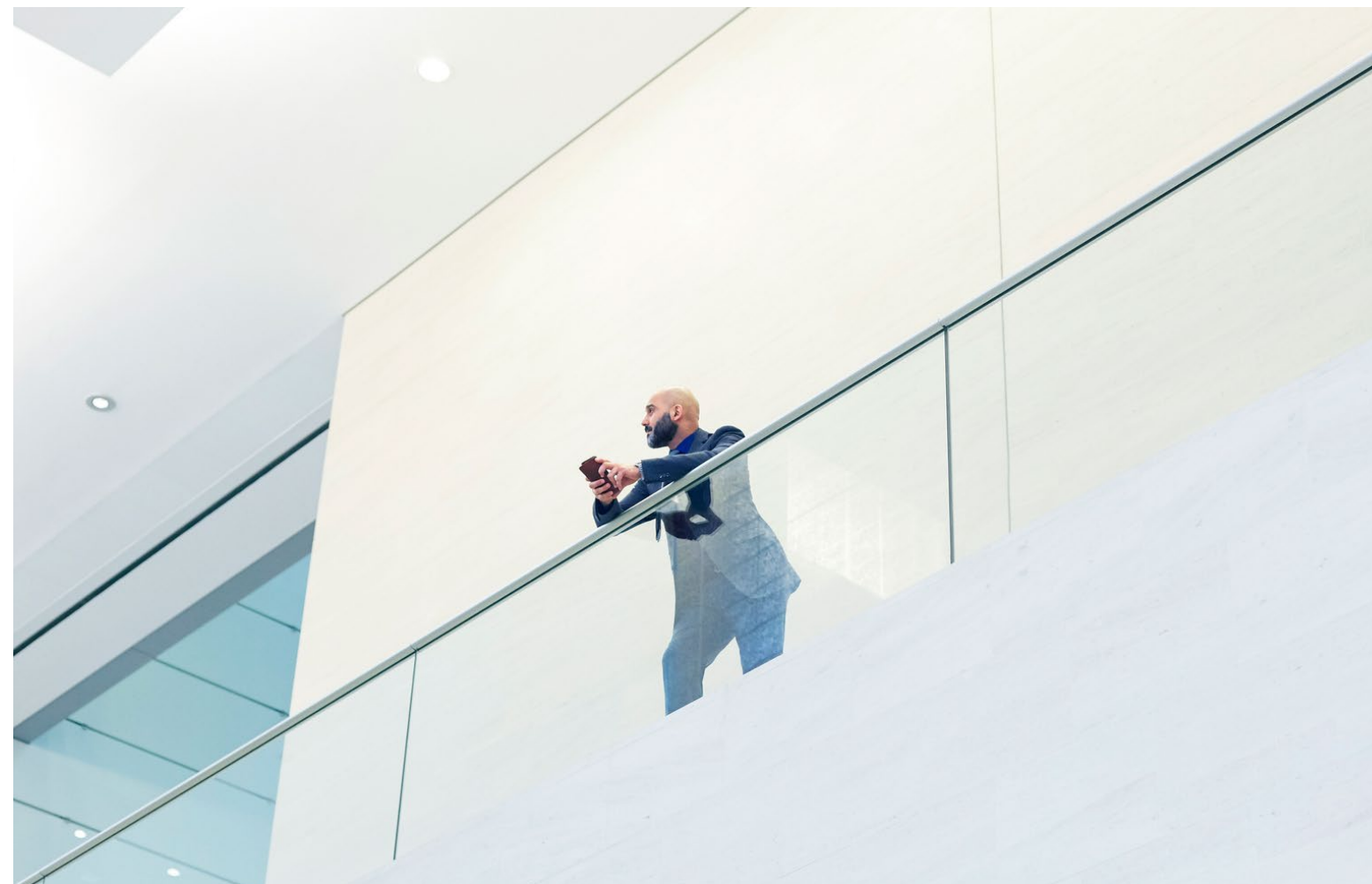

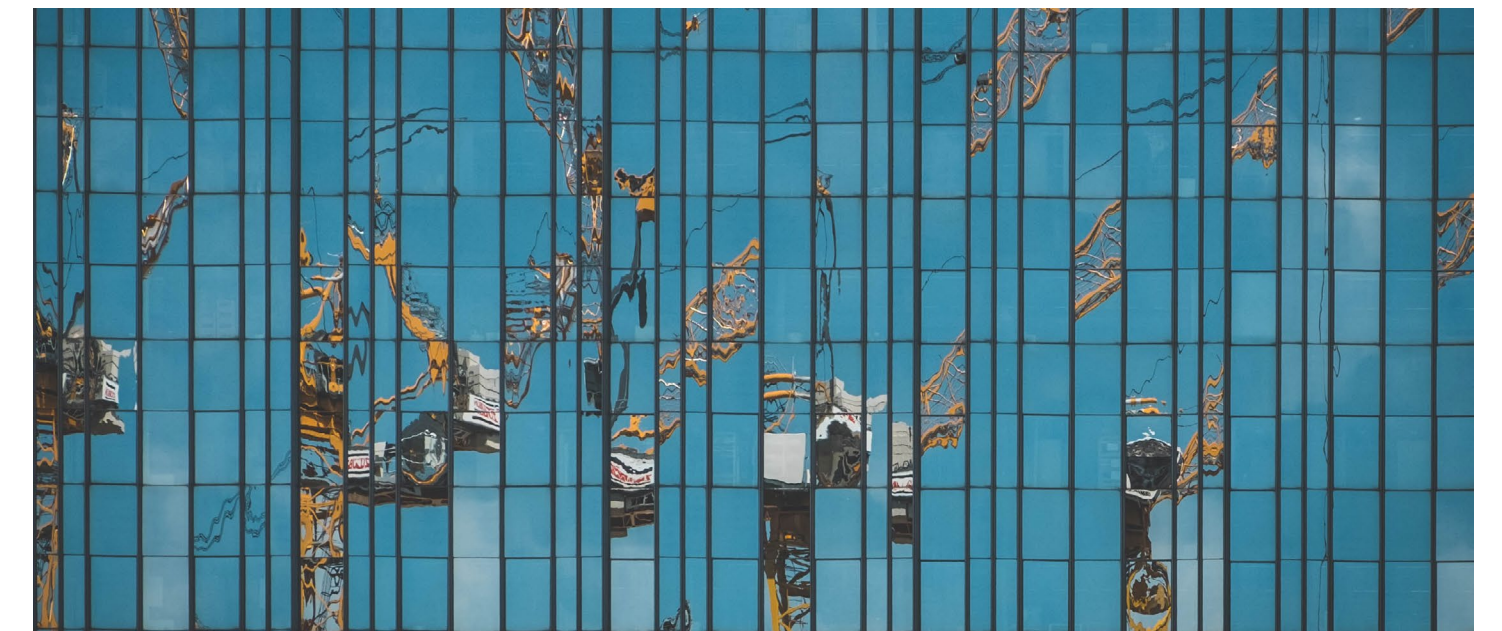

Arbitration can be used to resolve family disputes, both in respect of financial and children matters, whether from the outset or in parallel with traditional litigation.

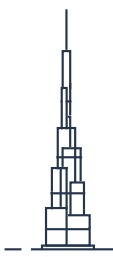
