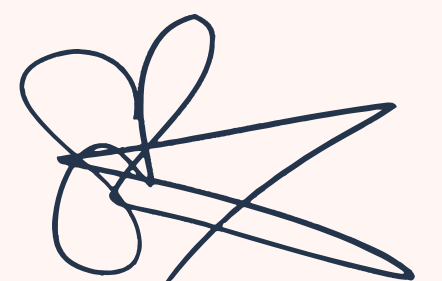

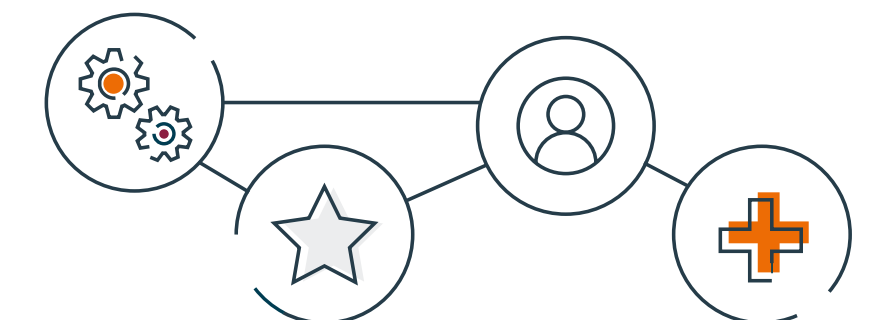

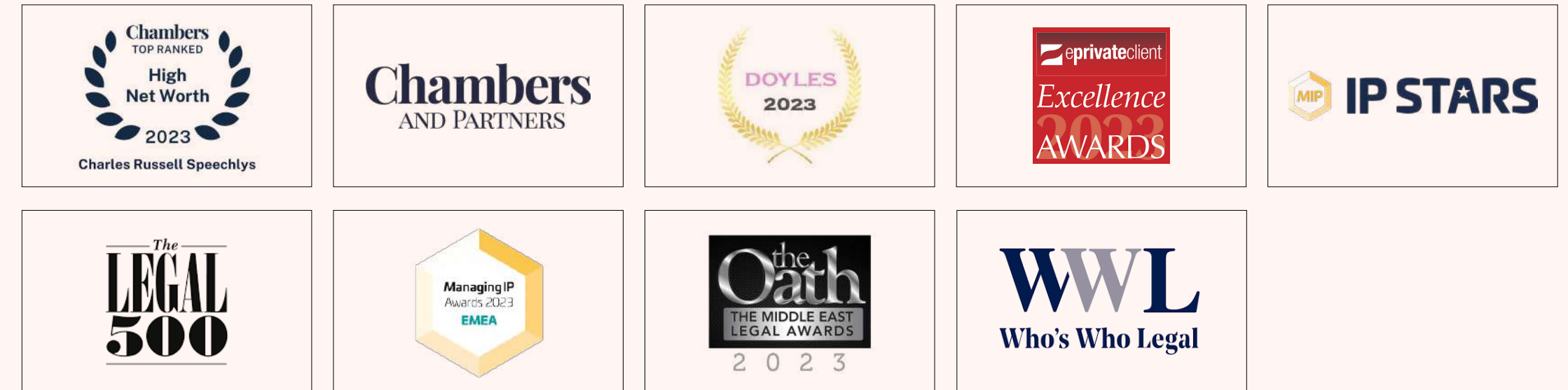

We do that by creating an inclusive work environment where everyone can be comfortable being their whole self and committing to targets and action to drive more diversity in our partnership.

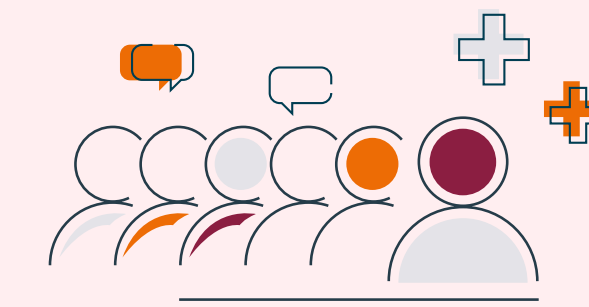
We're committed to achieve net-zero carbon emissions by 2030 and working with our suppliers to bring them on board too.

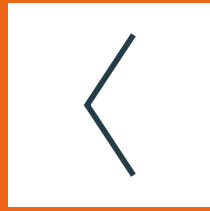
